The Montgomery Bus Boycott

- ① On December 1, 1955, Rosa Parks was arrested in Montgomery, Alabama, after she refused to give up her seat to a white passenger on a city bus. Her arrest was not the first challenge to segregated buses, but it became a powerful focus for local activists. That evening, members of the Women's Political Council called for Black residents to stay off city buses on December 5. They distributed thousands of leaflets through schools, churches, and neighborhoods.
- ② On December 5, most Black bus riders in Montgomery walked, shared cars, or used Black-operated taxis instead of riding buses. That day, community leaders formed the Montgomery Improvement Association and chose Martin Luther King Jr. as its president. The group asked people to continue the boycott until the bus company treated riders fairly. To help people travel, volunteers organized carpools, while churches collected money for gasoline and repairs. The boycott required daily planning and cooperation, not simply one day of public protest.
- ③ City officials and bus company leaders tried to weaken the protest, but many participants continued for more than a year. Meanwhile, lawyers challenged bus segregation in federal court. In November 1956, the Supreme Court upheld a lower court decision that Alabama's bus segregation laws were unconstitutional. Montgomery's buses were officially desegregated on December 21, 1956. The boycott showed that organized local action, combined with legal challenges, could change unfair public policies. It also became an important example for later civil rights campaigns.
