Voices from Harlem

- ① In the 1920s, Harlem in New York City became a center of Black art, publishing, music, and debate. This period, often called the Harlem Renaissance, developed during the Great Migration, when many Black Americans moved from the rural South to Northern cities. Poets wrote for readers who were building new communities while facing job limits, segregated spaces, and racist violence. Their poems did not simply report events. Through voice, rhythm, setting, and image, writers explored pride, anger, fatigue, hope, and the demand to be seen as fully American.
- ② Langston Hughes's 1925 poem “The Weary Blues” places a listener in a Harlem setting, where he hears a musician play late at night on Lenox Avenue. The musician's blues performance is marked by repetition, a heavy rhythm, and words about being unable to feel satisfied. These features echo blues music, an art form shaped by Black experience. The poem records exhaustion, but it also gives the musician's voice space and attention. By bringing street music into print, Hughes treats everyday Black cultural expression as worthy of serious art.
- ③ Claude McKay's 1919 sonnet “If We Must Die” answers a different pressure, racist mob violence directed at Black Americans after World War I. Its speaker addresses a group threatened by attackers and urges them to resist with dignity rather than submit in terror. McKay uses the formal sonnet, a structure long associated with European literary tradition, alongside urgent language of collective defense. That combination challenges ideas about whose voices belong in prestigious poetry. The poem reflects a time of danger, while its direct address turns fear into solidarity and action.
