### A Novel With an Argument

- ① In 1904, writer Upton Sinclair spent seven weeks investigating Chicago's meatpacking district and gathering details for a novel. Sinclair was a socialist who believed that powerful business owners profited while workers carried the risk. Those beliefs shaped what he noticed and emphasized. In *The Jungle*, published in 1906, he follows Jurgis Rudkus, a Lithuanian immigrant trying to support his family. By centering an immigrant laborer rather than a company owner, Sinclair directs readers to experience industrial growth from the worker's vulnerable position.
- ② Sinclair's circumstances also affected the novel's tone. Chicago's stockyards were an enormous center of production, yet many employees faced low wages, dangerous machinery, and unstable jobs. Sinclair wrote during the Progressive Era, when journalists and reformers investigated problems created by rapid industrialization. He uses grim sensory details, including spoiled meat and exhausted bodies, to make readers feel disgust and alarm. This choice supports his argument that the economic system harms people. A writer hired by a packing company might have stressed efficiency, affordable food, or jobs instead, producing a sharply different account.
- ③ The book influenced a national debate, but not entirely in the way Sinclair hoped. Many readers reacted most strongly to its descriptions of contaminated food. In 1906, President Theodore Roosevelt supported federal action after reading the novel and receiving an investigative report about packing plants. Congress passed the Meat Inspection Act and the Pure Food and Drug Act that year. Sinclair later wrote, "I aimed at the public's heart, and by accident I hit it in the stomach." His comment shows that his worker-centered purpose differed from many readers' concerns.

**PART 3 • YOUR TURN (SAMPLE ANSWER)**

A parent who works an early shift might write that cutting a bus route threatens students' attendance because the parent has no car and cannot drive them. Their work schedule would make them emphasize missed class time and unsafe walking conditions. A transportation director might explain that fewer riders and rising fuel costs require combining routes. Because the director must balance a district budget, that speaker might use numbers about costs and seat capacity instead of describing families' daily routines.
