A Renaissance in Harlem

- ① The Harlem Renaissance was a flowering of African American art and writing centered in Harlem, New York, during the 1920s and early 1930s. The Great Migration brought many Black families from the South to northern cities, creating new communities, audiences, and publishing opportunities. Writers, musicians, and visual artists explored what it meant to claim Black identity in a nation shaped by racism. Their work did not follow one single style. Some artists celebrated city life and modern culture, while others drew on Southern speech, folklore, and memories. Together, they challenged readers who expected narrow or stereotyped portraits of Black Americans.
- ② Poet Langston Hughes listened to jazz and blues in Harlem clubs and brought their rhythms into poems. In "The Weary Blues," a speaker hears a pianist play and sing late at night. Repeated sounds, musical phrasing, and spoken language make the poem feel close to a performance. Hughes wrote about ordinary people, work, dreams, and racial injustice. His poems often honor Black life without pretending that life is free from pain. By placing blues music on the printed page, he showed that a form created in Black communities belonged in American literature.
- ③ Zora Neale Hurston used her training in anthropology to record stories, songs, and speech from Black communities. Her novel *Their Eyes Were Watching God* follows Janie Crawford as she seeks love, independence, and a voice of her own. Hurston combines standard narration with dialogue shaped by Southern dialect, allowing characters' voices to carry the story. Claude McKay, a Jamaican-born writer, used a different approach. In his sonnet "If We Must Die," tightly patterned rhyme and a forceful, formal voice turn resistance to racist violence into a call for courage. Hurston and McKay show that Harlem Renaissance writers could use very different forms while examining identity, power, and self-definition.

PART 3 • YOUR TURN (SAMPLE ANSWER)

Zora Neale Hurston's novel *Their Eyes Were Watching God* follows Janie Crawford as she searches for love, independence, and her own voice. A central theme is self-definition. Hurston uses dialogue shaped by Southern dialect alongside standard narration. This contrast lets characters' own speech show their lives and supports Janie's effort to claim a voice.
